New Market Tax Credit Program RDC serves as the allocatee for the Community Development Financial Institution's New Market Tax Credit (NMTC) Program. This program is designed to generate private sector capital investments in low-income areas. During the current year, PIDC-RDC settled two NMTC transactions, providing \$45 million to mixed uses, extended stay hotel, and research & development projects.

Below Market Lending - PIDC-RDC provides funding at below market interest rates for capital projects that retain and grow employment within the City of Philadelphia. The participant's benefit is equal to 2.0% of final average compensation multiplied by years of service (not in excess of 35 years), less 1.0% of the Social Security benefit multiplied by years of service (not in excess of 35 years). Pursuant to generally accepted accounting principles, management is required to determine the present value of the defined benefit plan liability, which considers various factors, including number of years until the participant's eligible retirement age, a discounted interest rate, and the expected return of the defined benefit's plan assets. During 2011, because of current economic market conditions the discounted interest rate assumption decreased by 125 basis points, which caused the present value of the defined benefit plan's liability to increase substantially. The impact of the increase in the present value of the defined benefit liability to an individual's deferred compensation is reflected in "retirement and other deferred compensation" in Schedule J-Part II Column (c). The increase in the present value of the defined benefit plan's liability does not correspond to the actual benefit due to the Plan participants that is based on the compensation structure and years of experience, for which there were no significant changes during 2011.
