Founded in 1969, the Connecticut Council for Philanthropy is the state's regional association of grantmakers Its members include family, independent and community foundations, corporate foundations and giving programs and federated funds that fund in Connecticut The work of the Council benefits the larger grantmaking community, the nonprofit community, and the public, as well as its members Knowledge and Information - The Council compiles data and information on grantmaking and charitable giving in the State, provides analysis and context, and disseminates knowledge broadly to the philanthropy sector Regular publications include Capital Campaigns Reports for Greater Hartford, Greater New Haven and Fairfield County, Community Foundation Survey, Giving in Connecticut, Ways to Share, A Holiday Wish List, Toolkit for Giving, Connecticut Network of Community Foundations brochure, Guiding Principles and Effective Practices for Grantmakers, the Connecticut Philanthropy Digest and Connecticut Grantmakers Online, a web-based directory of over 2,100 Connecticut funders with over 160 subscribers state-wide Education and Professional Development - During 2011 the Council presented more than 81 programs for close to 1,747 attendees focused on providing grantmakers with learning and networking opportunities to help them in their work These include programs and workshops on topics of interest to funders as well as "how-to" sessions that focus on building particular skills The programs are delivered in locations around the State to help grantmakers make the most of their giving The Council currently supports 6 affinity groups focused on Aging, Early Childhood Education, Green Jobs, Health, K-12 Education, and Women's & Girls Funds Connections among grantmakers and others - The Council provides opportunities for grantmakers with common interests to come together to share knowledge and experiences The Council also supports and encourages the collective action of grantmakers to enhance the outcomes of their grantmaking Periodically it also offers grantmakers and grantseekers the opportunity to engage in dialogue The Council actively manages its website which is a compendium of local and national resources, timely news and updates The Council represents the interests of its members at numerous meetings, both local and national Leadership - The Council is a leader in enhancing philanthropy in Connecticut It serves as an advocate for philanthropy by sharing with elected and appointed officials, the media and the general public the importance and impact of philanthropy for the public good in the state
