The Cooperative Development Foundation (CDF) is a 67-year old 501(c)(3) non-profit foundation organized under Illinois state statutes with headquarters in Washington, DC. CDF was created in 1944 by the National Cooperative Business Association (NCBA) and the U.S. cooperative community to help European cooperatives after World War II. In the 1960s its focus changed to domestic cooperative development. CDF's mission today is to promote community, economic, and social development through cooperative enterprises. CDF does this by raising and distributing funds for economic and community development projects building partnerships that create cooperative solutions to today's economic problems raising awareness of the role cooperatives play in the nations and the world's economies. CDF's resources are used to support cooperative development through direct expenditure and grants and loans to cooperatives and cooperative organizations. CDF manages nine funds (not including it
