The Foundation is instrumental in developing the Montana Cardiology Telemedicine Network (MCTN) The telemedicine infrastructure provides patients and professionals with real-time access to cardiologists located miles away at the International Heart Institute, a division of St Patrick Hospital and Health Science Services Center The network uses advanced technology to improve healthcare in rural physician offices, hospitals and tribal clinics throughout Western Montana The Foundation received a three-year grant from HRSA - the Office for Advancement of Telemedicine (OAT) to finance a study of the efficacy and efficiency of telemedicine in the provision of home health care The Grant funds telemedicine equipment for a consortium of home care providers in western Montana and funds the collection and analysis of data related to clinical and financial performance of use in very rural environments

The Compassion Fund is directed primarily to employees in order to assist them in times of extreme or catastrophic difficulty The Fund is mainly supported by employee contributions from the Spirit of Giving Program (30 Minute Club) and must be limited in annual benefits to the amount of funds raised through the 30 Minute Club or other avenues

SJMC Klein MD Memorial Cancer Center - St Joseph Medical Center's Cancer Center underwent a remodel project and was renamed the Otto Klein Cancer Center In March 2011, the Otto Klein Cancer Center officially opened at Providence St Joseph Medical Center The Otto Klein Cancer Center offers the convenience of receiving cancer treatment at St Joseph Medical Center in Polson rather than traveling to Missoula for weekly chemotherapy treatments People undergoing chemotherapy need to focus on getting well and travel after treatment is not optimal The third floor of Providence St Joseph Medical Center has been completely remodeled to provide a high level of care to each patient The Cancer Center now includes two exam rooms, two treatment rooms with space for eight patients to receive chemotherapy treatment comfortably, a waiting area including a kitchen and a supportive care counseling center to help patients and families confront the illness
