The Foundation's purpose is to raise private funds and manage assets for the benefit of The Congregational Home, its residents, programs, staff and facilities. In late 2008 The Congregational Home purchased approximately 4.25 acres of contiguous real property in the middle of its campus. The buildings were demolished in 2010 and the process of converting the site into an integral part of resident life continues. The major focus of the Foundation throughout 2011 was to continue collecting on capital campaign pledges to assist the Home in retiring the property acquisition indebtedness and to encourage philanthropy through annual and planned gifts.
