NOCSAE funded research resulting in the publication of more than ten peer-reviewed scientific journal articles on the topic of concussions in sports, injury epidemiology, and equipment performance. In addition, the Center for Injury Research and Policy at Nationwide Children's Hospital in Columbus, Ohio, in affiliation with Ohio State University, maintains a high school sports injury surveillance program and publishes results of that data with significant grant support from NOCSAE.

Establishment of athletic equipment standards through related research. On the basis of grant-funded research, and direct contracted research, NOCSAE has drafted three new standards for baseball and softball protective headgear and face gear for defensive players, a youth football helmet standard, and is investigating the feasibility of a lacrosse helmet standard for women. Expenses are included in 4c.

Enhancement of the integrity of the NOCSAE standards and licensee compliance. This figure includes \$252,398 spent in maintaining and improving the integrity and accuracy of certifications made regarding compliance of specific equipment to the NOCSAE standards, and in modifying certain language in some standards, as well as collecting and reviewing testing certification data from many of its licensees, and in performing direct product testing where evidence was provided of a potential product failure. The total figure also includes \$273,057 apportioned from legal and administrative expenses to the enforcement of license agreement compliance and performance, litigation to enforce termination of noncompliant licensees, and compelling compliance with certain license agreement terms regarding product quality control and quality assurance.

(Code) (Expenses \$ 696,877 including grants of \$) (Revenue \$)

Developed a joint educational program called Heads Up to Parents focused on dissemination of information to parents of children exposed to concussion risk in athletic activities. Public relation expenses included the development of an Internet-based pay per click program intended to provide Internet search results that would direct people to the NOCSAE website where they can obtain information regarding helmet performance, concussion prevention, diagnosis, and return to play criteria, in addition to providing access to summaries of recent pertinent research on the issue of concussions in sports. In addition, the PR team prepared and disseminated regular informational releases to selected & publication outlets addressing concussion topics and discussions in the news.
