THESE BLOCK GROUPS ARE LOCATED IN PROVIDENCE (3 BLOCK GROUPS), CENTRAL FALLS, PAWTUCKET, AND WOONSOCKET. THE STATEWIDE CLEAR CORPS PROGRAM RELIES ON A PARTNER FOR MARKETING, OUTREACH AND ENROLLMENT, THE REMEDIATION AND CERTIFICATION OF A LEAD SAFE STATUS IS COORDINATED AND PERFORMED BY CLEAR CORPS STAFF MEMBERS WHO ARE CERTIFIED AND LICENSED BY THE STATE AS LEAD REMEDIATION CONTRACTORS. OUR LEAD REMEDIATION EFFORTS RESULTED IN OVER 700 HOUSING UNITS CERTIFIED AS LEAD SAFE BY YEAR END 2011.
