AT A TIME WHEN NONPROFIT DOLLARS ARE MORE IMPORTANT THAN EVER, ST JOHN UNITED WAY'S ALLOCATION PROCESS STRIVES TO BE AN OBJECTIVE AND FAIR APPROACH TO SUPPORTING ORGANIZATIONS THROUGHOUT ST JOHN THE BAPTIST PARISH. THE PROCESS INCLUDES ALL AGENCIES REQUESTING FUNDING TO SUBMIT AN APPLICATION, WHICH ARE REVIEWED BY THE STAFF AND VOLUNTEERS. IN 2011, ALL AGENCIES REQUESTING FUNDING WERE INTERVIEWED BY KEY UNITED WAY AND COMMUNITY STAKEHOLDERS TO LEARN MORE ABOUT FISCAL PRACTICES AND PROGRAMS. ST JOHN UNITED WAY REMAINS COMMITTED TO EDUCATION AND HELPING CHILDREN SUCCEED. IN 2011, OVER 33 PERCENT OF FUNDING SUPPORTED PROGRAMS FOCUSED ON THE "SUCCESSFUL CHILDREN" IMPACT AREA. MOST NOTABLY IS THE MULTI-SYSTEMIC THERAPY (MST) PROGRAM PROVIDED THROUGH KINGSLEY HOUSE TO HELP REDUCE TRUANCY IN ST JOHN PARISH. OTHER IMPACT AREAS SUPPORTED WERE "STRONG FAMILIES" AT 23 PERCENT, "SAFETY NET" AT 22 PERCENT, AND "HEALTH AND INDEPENDENCE" AT 11 PERCENT. ST JOHN UNITED WAY ALSO HONORS DONORS' WISHES TO SEND DESIGNATIONS OUTSIDE OF THE PARISH. THIS REPRESENTS AN ADDITIONAL 11 PERCENT OF ALLOCATIONS FUNDING.
