Clinic Services Napa Humanes professional veterinary team is dedicated to ending pet overpopulation. We operate a low-cost, high quality Spay/Neuter Clinic serving companion animals throughout the Napa Valley. In 2011, a record 4,831 spay or neuter surgeries were performed by our team with our one surgery suite operating 251 days. Additionally, Napa Humane is an important link in keeping a healthy population of pets and people by holding a weekly affordable vaccination/microchipping clinic. In our 3 5 hour weekly vaccination clinic in 2011 we vaccinated 2,567 pets and microchipped 1,771 companion animals.

Humane Education Our outreach efforts engage hearts, hands, and minds for animals. We are in classrooms each week of the school year with programs such as Responsible Pet Care and Safe with Cats and Dogs. We have also created a live puppet performance, The Right Pet for Princess Penny, presented in assembly format of 200-400 children per show, and provide a curriculum-based activity book to each child to reinforce the humane lessons presented. We sponsor annual subscriptions to KIND News (Kids in Natures Defense) to over 100 classrooms reaching 3,000 students, and we offer the community classes Introducing Your Pet to your New Baby, Kitten 101, Bunny Basics, and Pet First Aid.

Shelter Support Services We are at the heart of helping homeless animals in our community. We use our Mobile Adoption Unit to take animals from the Napa County Animal Shelter out into the community, and we help to re-home Shelter pets by leading a cadre of volunteer photographers to take appealing pictures of the animals that show their personalities outside of their caged environment, posting the photos on websites such as Petfinder.com to create the most exposure possible for a pet in need of a home. We formed the Community Cat Cooperative, working with the Shelter and other community partners to address the needs of "loosely owned" cats in the Valley.

		One of our board members, Jennifer Byram, is a partner in the law firm of Coombs & Dunlap LLP. The Humane Society of Napa County and SPCA, Inc, in conjunction with three other charities, contracted with Coombs & Dunlap LLP to provide legal services. The law firm represented the charities in asserting the charities' rights to bequests from the Dolores R. Fry Revocable Trust. The Dolores R. Fry Revocable Trust named four charities as the remainder beneficiaries. The charities became aware that the trustee had misappropriated the trust funds, so the bequest to which they were entitled had been taken. After reviewing the facts, Napa Humane decided to pursue claims against the trustee on behalf of itself and the other three charities. The total potential damages were estimated to be approximately \$2,000,000. Another beneficiary also filed suit against the trustee, so litigation was risky. Napa Humane contracted with Coombs & Dunlap, LLP, to pursue the litigation on a contingent fee basis. Because the recovery was speculative, and involved both breaches of fiduciary duty, complicated estate tax questions, and another plaintiff competing for the same damages, the contract was for a 50% contingency. The litigation was eventually resolved by settlement confirmed by the court in November, 2010. To date, the settlement has provided over \$460,000, after attorney fees, to the four charities, distributed partially in 2010 and partially in 2011. There is one more outstanding issue that may provide an additional \$125,000. The attorney fees were paid from the settlement monies before distribution to the charities, so each charity paid 25% of the total attorney fees. To date, attorneys and staff at Coombs & Dunlap have dedicated over 1,285 hours to this litigation, which at regular hourly billing rates would exceed \$440,000 in fees.
