THE LEAVING HOMELESSNESS BEHIND PROGRAM WAS STARTED AS A SOLUTION TO WORKING WITH HOMELESS FAMILIES WHILE THEY ARE ON THE HOUSING CHOICE VOUCHER WAITING LIST. THIS PROGRAM WORKS WITH CLIENTS TO OBTAIN SELF-SUFFICIENCY GOALS AND IS OPERATED VERY SIMILARLY TO THE FAMILY SELF-SUFFICIENCY PROGRAM, EXCEPT IT OPERATES COMPLETELY ON PRIVATE DONATIONS AND GRANTS. IN 2011, 16 CLIENTS ENTERED THE PROGRAM AND 2 CLIENTS GRADUATED INTO THE HOUSING CHOICE VOUCHER AND FAMILY SELF-SUFFICIENCY PROGRAMS.
