Pregnancy testing provided for 184 women and friendship counseling for 300

98 babies born to mothers we served. 58 mothers received maternity clothing and 53 babies received baby clothing.

Actual (not estimated): 29 mothers assisted in purchasing cribs and 26 in purchasing car seats. Friendship counseling volunteers staffed the office 43 hrs/wk and clerical and clothing volunteers 21 hrs/wk. Grant of \$8000 to Birthright U.S.A. hotline which is staffed 24 hrs/day, 7 days/wk.
