PART VI, Section C, Line 19 - All financial statements and governing documents are made available upon specific request and subsequent approval of the Board of Directors. Financial results and plans are presented in detail by the Treasurer at the annual corporate meeting.

Part XII, Line 2 c- Corporate By-Laws provide for an audit committee consisting of three members of the Board of Directors. Positions on the Audit Committee are filled bi-annually on a rotating basis to assure independence and objectivity.
