NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

This summary of significant accounting policies of Northampton County Medical Society is presented to assist in understanding the Society's financial statements. The financial statements and notes are representations of the Society's management who is responsible for their integrity and objectivity.

Nature of Operations: The Society operates as a nonprofit professional association to provide benefits to its membership. The membership and related dues and fees revenue are limited to physicians in the Northampton County, Pennsylvania area.

Method of Accounting: The Society prepares its financial statements on the modified cash basis of accounting, but includes depreciation of capitalized assets and liabilities for payroll withholdings. Under this basis, revenues are recognized when collected rather than when earned, and expenses are generally recognized when paid rather than when incurred. Consequently, the financial statements do not include accounts receivable, accounts payable to vendors or suppliers, and accrued expenses other than those described above, as of December 31, 2011 and 2010.

Investments: The Organization carries investments in marketable securities with readily determinable fair values and all investments in debt securities at their fair values in the statement of financial position. Unrealized gains and losses are included in the change in net assets in the accompanying statement of activities.

Property, Plant and Equipment: Office equipment is carried at cost less accumulated depreciation of \$26,987 and \$26,035 as of December 31, 2011 and 2010, respectively. Depreciation is provided for using the straight-line method over the estimated useful lives of the assets. Depreciation expense for the years ended December 31, 2011 and 2010, was \$953 and \$815, respectively.

Cash Equivalents: For purposes of the statement of cash flows, cash and cash equivalents includes only checking accounts and money market accounts.

Use of Estimates: The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Management's Review: The date to which events occurring after December 31, 2011, the date of the most recent balance sheet, have been evaluated for possible adjustments to the financial statements or disclosure is September 11, 2012, which is the date of which the financial statements were available to be issued.

NOTE 2 INCOME TAXES

The Northampton County Medical Society is an organization exempt from taxation under Section 501(c)(6) of the Internal Revenue Code. No provision for income taxes has been reflected in the accounts.

NOTE 3 DUES COLLECTED/TEMPORARILY RESTRICTED ASSETS

The Society collects only the Northampton County Medical Society share of dues. During 2011 and 2010, the Society received dues for the subsequent membership year. These prepaid dues are accounted for as temporarily restricted net assets

NOTE 5 FAIR VALUE OF FINANCIAL INSTRUMENTS AND CREDIT RISK

The fair value of investments are estimated based on quoted market prices. Market risk and the related risk of accounting loss could occur and are dependent on the future changes in market prices of the investments held.

Financial instruments that potentially subject the Society to concentrations of credit risk consist principally of temporary cash investments. The Society places its temporary cash investments with financial institutions and limits the amount of credit exposure to any one financial institution. Money market accounts are held by a securities broker and are not insured by the Federal Deposit Insurance Corporation.

NOTE 6 LEASE OBLIGATION

Rental expense is presently on a month to month basis at the rate of \$1,044 per month. Rent includes utilities, outside maintenance and refuse expenses. Rental expense for the years ended December 31, 2011 and 2010, amounted to \$11,528 and \$13,528, respectively.
