

For the 11th consecutive year, the Trust has fallen below the 33-1/3% public support requirement. Accordingly, the Trust is submitting this "facts and circumstances" statement to confirm and to justify its continued status as a publicly supported organization described in section 170 (b) (1)(A)(vi) of the Internal Revenue Code of 1986, as amended (the "Code"). As an initial matter, it should be noted that the current public support situation exists because of a very large gift received from one foundation during the fiscal year 2000, and the resulting investment income of the Trust.

In 2003, 2004 and 2006 gifts of \$99,980; \$100,000; and \$200,000 were received in celebration of the University's centennial anniversary and other worthy causes. We do not expect these large contributions to continue.

With respect to the facts and circumstances test, the Trust continues to receive a substantial amount, if not all of its support from the public, as evidenced by the following:

(1) As a result of the above referenced gifts and income, the Trust's public support was reduced as follows: 2000-28%; 2001-21%; 2002-24%; 2003-29%; 2004-24%; 2005-19%; 2006-21%; 2007-24%; 2008-23%; 2009 - 26%, 2010 32%, and 27% in 2011

It should be noted that the results of the Trust's public support test is still well above the 10% public support fraction required to satisfy the facts and circumstances test.

(2) The Trust continues a bona fide and regular program of solicitation to alumni and friends of Rhodes University. The program takes the form of solicitation letters and emails, which are typically sent out twice a year.

(3) The purpose of the Trust is to provide funds to leading and world-renowned educational institutions, including Rhodes University in South Africa. These educational institutions, in turn, make their programs and research available to the general public.

(4) The Trust's Board of Trustees comprises 12 individuals and is a diverse group of academicians, marketing, legal, investment and financial professionals, journalists, and business leaders from North America.

In summary, the Trust continues to receive substantial public support and believes that this below 33-1/3% public support fraction is due to easily identifiable circumstances, and are temporary in nature. Accordingly, the Trust requests that its public support status under Code section 170(b) (1)(A)(vi) be continued without interruption.
