**Statement of Program Service Accomplishments**

In 2011, Media Mobilizing Project (MMP) launched 5 public computer labs, placed over 40 volunteers and trained 248 low-wage workers, young people, immigrants and other community and labor leaders in communications and computer skills, digital storytelling, and media production. MMP drew 45 leaders from these trainings and other programs into an intensive training institute on the nature of media and communications in our city as they relate to our everyday struggles around health, housing, jobs, and education. MMP also produced over 10 hours of pro-bono radio coverage and 200 minutes of pro-bono video work in collaboration with other nonprofit organizations in Pennsylvania, and provided strategy and support for 10 nonprofit organizations. On the national level, MMP framed the terms of the debate around poverty by teaming up with PBS broadcaster Tavis Smiley and Princeton professor Dr. Cornel West to produce 5 documentary segments about the plight and fight of poor and working people in the United States, which aired nationwide on PBS in October, reaching 2.5 million viewers.
