HEART FOR LEBANON OFFERED \$85,000 WORTH OF SCHOLARSHIPS FOR CHILDREN BETWEEN THE AGES OF 6 AND 12. THESE SCHOLARSHIPS WENT TO 9 DIFFERENT SCHOOLS IN DIFFERENT AREAS, FROM THE SOUTH TO THE BEKAA VALLEY IN THE EAST, TO BEIRUT AND ITS SUBURBS. EACH SCHOLARSHIP HELPED THESE STUDENTS PREPARE FOR THE FUTURE AND FULFILL AND THEIR DREAMS. HEART FOR LEBANON STAFF VISITED EACH SCHOOL AND EACH ONE OF THE STUDENTS HOMES THROUGHOUT THE ACADEMIC YEAR.
