The studies included examinations of marine bird statistics and the incidence of plankton in the Gulf of Alaska, analysis of ecosystem information to improve the decision support system for the salmon population in the central/northern California coastal area, and an examination of winter upwelling with respect to California current ecosystem dynamics. All studies were funded by contracts and subcontracts predominantly with government agencies. The results of these studies and of all of Farallon's research are held in the public domain for the benefit of the general public.
