Also, during the event a national career fair for college and high school students with disabilities takes place, bringing together employers and students with disabilities to provide education and available job opportunities.

General Education and Information Services - Includes webinars, exhibiting and speaking at conferences and events, and general dissemination of information related to inclusion of people with disabilities in the workforce. Disability Supplier Diversity Program (DSDP) - Connects disability-owned business enterprises (DOBES) to major corporations and each other for enhanced access to business opportunities.
