Shalom Christian Missions is dedicated to serving children in need throughout the world Our purpose is to preserve and protect the precious lives of orphans and other vulnerable children from going to waste By caring for them in their time of need, we hope to provide them with the opportunity to become responsible and caring adults who will take the love of Christ to all nations We are a 501(c)3 non-profit organization, dedicated to serving children in need throughout the world

28	Children Sponsorship Our sponsor program provides for the basic needs of the children in need, including food, clothing, medical care, education and shelter when required Our program faced an extream challenge this year with the discovery of fraud, disception and abuse of the children at the childrens center in Kenya We eventually found ourselves in a battle to replace the corrupt director and rescue the children We could not abandon the children so when our initial attempts failed to dislodge the director and the community members ask us to stay, we started a new childrens center New land was donated and a community board was formed The project was named New Beginnings and we immediately began transforming the donated mountainside land into a new childrens center The center immediately began to rescue the children and opened a new school by the end of the 2011 we had around 35 children in the program and 160 enrolled in the school (Grants \$ 23,200) If this amount includes foreign grants, check here	28a	23,200
