 In 2011, USA Together operated our web service and posted over 375 requests from injured and ill service members and families of the fallen. We purchased needed goods and services and paid bills for these service members in the form of \$108,087 for mortgage and rent; \$33,241 for car repair and loan payments; \$32,955 for groceries gift cards; \$22,309 for utility bills; \$21,330 for home repairs; \$11,920 for appliances and furniture; \$5,249 for travel expenses; \$2,927 for insurance payments; \$2,900 for medical bills; \$762 for electronics, \$590 for child needs including daycare; \$570 for college expenses and \$4,328 for miscellaneous (therapy bike, storage fees, payday loans). Additionally, USA Together made one \$4900 donation to another VSO assisting disabled and injured veterans and active duty service members.
