A. Remit4Change Program

Remit4Change program is TIGRA's main platform for promoting TIGRA-accredited remittance products and providing financial education to members of organizations. In 2011, we worked with a dozen organizations in the United States and recruited 4,000 individuals to use the Remit4Change platform as their preferred remittance program. TIGRA explored replication of Remit4Change in Mexico City and the Philippines. As of the end of 2011, TIGRA has accredited eight service providers.

B. Newcomers Program

TIGRA, along with its partners in the United States and the Philippines, set up a newcomers program that will provide financial education services to incoming immigrants to the United States from the Philippines. The program will reach 42,000 individuals who will come to the United States as permanent residents each year. The program includes an pre-departure orientation session in the Philippines, and services once they arrive in the United States. As part of this work, Transnational Community Reinvestment Fund is a global social investment fund aiming to address the root causes of migration.

C. Setting Standards on the International Phone Card Industry

To address the predatory practices of the international phone card industry, TIGRA, in partnership with The Utility Reform Network (TURN), works with 10 immigrant-based organizations in California to document consumer experiences and generate proposals for reform. TIGRA has documented the experiences of hundreds of phone card users and is building a network of Immigrant Consumer Advocates across the State to present their findings and recommendations to the California Public Utilities Commission.
