DIRECT CLASSROOM PROGRAM SERVICES THE PRIMARY ACTIVITY OF THE CHESS CLUB AND SCHOLASTIC CENTER OF ST LOUIS (“CCSCSL”) IS INSTRUCTING STUDENTS IN THE GAME OF CHESS. THE CLASSROOM ACTIVITIES OCCUR IN TWO (2) MODES: FIRST, AT THE CCSCSL CAMPUS AT 4657 MARYLAND AVENUE, ST LOUIS, MO AND IN PARTICIPATING “SATELLITE CLASSROOM” AT VARIOUS GRADE SCHOOLS AND SEVERAL HIGH SCHOOLS IN THE GREATER METRO ST LOUIS AREA (“PARTICIPATING SCHOOLS”). THERE ARE 4 FULL-TIME INSTRUCTORS AND 3 PART-TIME INSTRUCTORS WHO TEACH AT THE CAMPUS AND BETWEEN TWENTY (20) TO TWENTY-THREE (23) PART-TIME INSTRUCTORS WHO TEACH AT THE PARTICIPATING SCHOOLS, DEPENDING ON THE TIME OF YEAR. APPROXIMATELY, NINETY (90) STUDENTS ARE ENROLLED IN CLASSES AT THE CAMPUS AND THERE ARE MORE THAN ONE THOUSAND (1,000) STUDENTS WHO ARE ENROLLED IN THE PARTICIPATING SCHOOL CLASSES. FORMAL CLASSES AND TEXTBOOKS ARE USED IN BOTH EDUCATIONAL ACTIVITIES OF CCSCSL. A FULL-TIME CLASSROOM TEACHER IS PROVIDED FOR CHESS INSTRUCTION AT THE INNOVATIVE CONCEPT ACADEMY, AN ALTERNATIVE SCHOOL FOR AT-RISK YOUTH. IN 2011 THE STUDENT BODY WAS RACIALLY DIVERSE. DURING 2011, CCSCSL HOSTED 93 INTERNAL TOURNAMENTS AND 10 SPECIAL EVENTS WITH GUEST LECTURERS.

APPLIED EDUCATIONAL PROGRAM SERVICES CCSCSL HOSTS NATIONAL CHESS CHAMPIONSHIP-LEVEL COMPETITIONS TO MAKE ITS STUDENTS AWARE OF HOW FAR EACH STUDENT’S ACADEMIC ACHIEVEMENTS COULD TAKE HIM/HER. CCSCSL AFFORDS STUDENTS THE OPPORTUNITY TO SEE NATIONALLY RECOGNIZED PLAYERS “DO THEIR THING” AND COMPETE WITH ONE ANOTHER ON AN APPLIED EDUCATIONAL PLATFORM, I.E. CHESS STRATEGY AT CHAMPIONSHIP LEVELS. CCSCSL LEADERSHIP BELIEVES THAT NATIONAL TOURNAMENTS MOTIVATE ITS STUDENTS TO EXCEL AT LEARNING CHESS SO THEY TOO MIGHT SOMEDAY COMPETE FOR SUBSTANTIAL CASH PRIZES AS WELL AS ACHIEVE PERSONAL AND INTELLECTUAL RECOGNITION AND VALIDATION. THE CHESS CLUB AND SCHOLASTIC CENTER OF SAINT LOUIS HOSTED THE 2011 U.S. CHAMPIONSHIP, 2011 U.S. WOMEN’S CHAMPIONSHIP, AND 2011 U.S. JUNIOR CLOSED CHAMPIONSHIP. THE TOP 16 PLAYERS IN THE U.S. PLAYED IN THE U.S. CHAMPIONSHIP. THE TOP 8 FEMALE PLAYERS PLAYED IN THE WOMEN’S CHAMPIONSHIP. THE TOP 10 JUNIOR PLAYERS COMPETED FOR THE TITLE OF JUNIOR CLOSED CHAMPION AND OTHER MONETARY AND NON-CASH PRIZES. IN ADDITION TO THE NATIONAL CHAMPIONSHIPS, WE HOSTED AN INTERNATIONAL MATCH BETWEEN THE HIGHEST RATED U.S. PLAYER AND AN EQUALLY RATED PLAYER FROM RUSSIA. FINALLY WE HOSTED A KINGS VS QUEENS TOURNAMENT OF FIVE MEN AND FIVE WOMEN.
