Our activities can be grouped into two major categories. First, we mentor and edify our membership through the study of the Bible. From this they are strengthened spiritually, they gain a greater understanding of the Bible, and are equipped to minister to others. Secondly, we assist other ministries around the world as they feed and minister to the poor. A vast majority of the offerings we receive is given to these organizations—thus, the name conduit. Currently we are helping Restoration Ministries in Haiti, World Vision in Rwanda and Place of Hope in Columbia, TN. When possible we organize mission trips, so that our membership, and others, can have a “hands on” experience building and repairing the facilities, feeding/serving the people and ministering the Gospel of Jesus Christ.

The Service granted exemption as a church on March 19, 2009, and a Form 990 has never been filed. See the attached determination letter.

In time this small operation has grown tremendously on both sides of the mission objectives—the church and the foreign and domestic mission support. In January 2011 we rented space for the church, obtained an EIN (27-4665498) for the church, and split the operations. Conduit Mission continues the same mission objectives as originally described. It is just on a larger scale.

The current activities include:

Continued assistance with building homes in Haiti following the earthquake. Over \$170,000 has been raised and 17 houses have been or are being built. This work is not limited to finances. We have supported a contractor and multiple mission trips with hands on workers.

Support for Mentor Leaders with a project in a remote village in Togo, Africa. Houses and a church/school have been built. Wells have been dug. Mission trips have also been sponsored for this work. Additional financial assistance sponsors an orphans’ feeding program.
