 Portland Jobs with Justice Education Fund is established as a coalition of labor unions, community, religious & student orgs & ind. activists with the purpose of defending the rights of all working people and preserving civil and economic rights for all members of the community; the right to a decent standard of living, the right to job security, and the right to organize. JwJ is based on direct action and solidarity; people making a pledge to support each other's struggles whenever and wherever they arise.

 Education around the economic crisis and support for collective action by particular groups of workers. We organized a project called Portland Rising which put thousands of workers and supporters in action together. We supported nine different campaigns including helping 900 county workers win a good contract, 200 security guards win a fair process for organizing, 900 hospital workers improve their working conditions, 160 community college faculty keep their standard of living and 120 hotel workers move from poverty wages to somewhat better conditions. We continue to support other worker campaigns, including postal workers who are engaged in trying to save the public postal service. In that campaign, we held a public hearing, helped with a lot of public outreach, and mobilized our base for several public rallies.

4b (Code:) (Expenses \$ 21,279 including grants of \$ 21,279) (Revenue \$)
 Our health care work is focused on educating the public about the need for affordable health care for everyone. We started the year with a health care conference at a downtown church which brought over 600 people together to talk about the health care crisis and start to organize. We brought organizers from Vermont to Oregon for a statewide tour educating the public about Vermont's Health Care is a Human Right campaign. We reached several thousand people across the state. We built a new coalition, Health Care for All Oregon, with fifty organizational members. We continue to lead the organizing for health care as a human right in the Portland area.

 Our immigrant rights committee was one of the key organizations building a coalition called ACT for Dignity and Justice to stop the collaboration of Immigration enforcement and local law enforcement. This collaboration leads to deep levels of fear in immigrant communities and reluctance to call the police. We have supported the ACT coalition in educating the public about these issues through a number of public demonstrations. We have educated many members of our member organizations about these issues.
