AWP has established two field offices in Georgia and one in South Carolina out of which six trained advocates provide services At this writing, the year-to-date accomplishments include permanently housing 92 formerly homeless veterans, enrolling in school or finding jobs for 120 formerly unemployed veterans, and assisting 669 military/veterans with various issues Other accomplishments include providing the model for other organizations in Charlotte, NC, Dallas, TX, Birmingham, AL, and other communities Also, AWP's outreach for the year has included major participation in the Thunder Over Augusta event which drew more than 20,000 people, hosting the Lt Dan Band Concert on Fort Gordon, which drew several thousand and various job fairs, recreational events and other community collaborations to raise awareness
