The organization developed an educational piece regarding protecting children against sexual abuse that is included with all vehicle registration renewals Since 95% of childhood sexual abuse is preventable through education and awareness, the goal is to reach as many individuals with direct messaging as possible The program that allows Lauren's Kids to provide an educational insert in motor vehicle registration renewal notices assures that over 5 million individuals will read the material this year In December of each year a targeted program occurs in Driver's License Renewal Offices where close to 50,000 individuals are provided with educational materials on how to better protect our children from predators and pedophiles

The organization puts on an annual walk to raise awareness about sexual abuse and urge those who have been abused to speak up The walk commences in Key West, Florida, the southernmost point of the US and covers over 1,500 miles, literally touching every area of the State of Florida Thousands walk at different stages of the "Walk in My Shoes" and the lives of tens of thousands are touched along the way The Founder and CEO of Lauren's Kids, herself victim and now survivor, walks all 1,500 miles and stops daily at Sexual Assault Treatment Centers, Child Advocacy Centers and schools, spreading not only a message of awareness and education, but also empowering victims to know that it is ok to tell and to know they too can become thriving survivors

The Organization is involved in the development of the curriculum and related materials that the state of Florida is implementing in all public kindergarten classes The curriculum, known as "Safer, Smarter Kids", has now been distributed to all public elementary schools in the state, over 10,986 kindergarten classrooms and thousands into early childhood programs (VPK) Pre and post testing has been done and first year results show a 77% learning gain in personal safety information by kindergarteners who were taught the curriculum
