Received 110,500 from SC Department of Education for a 21st Century Community Learning Center (CCLC) grant to implement a 7 week summer camp, for 59 at risk boys ages 9 to 17. Held on the campus of Wofford College we provided services according to the grant proposal, including Character Education, Academic Support, Enrichment, Curriculums and healthy meals and snacks. According to the Memorandum of Agreements included in grant proposal we used contractual services for things such as overnight dorm stay at Wofford, use of a church for parents days and other activities, Curriculum, science teacher, PE teacher, robotics, on campus food services, transportation and field trips. Employed 6 individuals, 40 hours for 7 weeks.

Weatherization - in partnership with Piedmont Community Action (PCA) of Spartanburg County weatherize homes for low income people who met PCA criteria. Improved living conditions and lowered cost of utilities. Provided employment for 16 individuals. To weatherize we - Insulated attics, floors, walls; caulked windows; completed pre and post blower door testing; installed moisture barrier under houses; replaced bulbs with CFL lights; installed water saver kits; wrapped water lines and hot water heaters; sealed attics and vents, put in CO alarms and smoke detectors, replaced or installed exhaust fans in bathrooms; installed dryer vents and ensured they were vented to outside of dwelling; and replaced HVAC filters.

Project "I Can Symposium" dealt with the plight of the black male, the 50% drop out rate of all males and the 15% unemployment rate among minorities in Spartanburg County.
