



**Part III Statement of Program Service Accomplishments**

**Capacity Building Training:** SICF and The Children's Village of NY created a curriculum to train Iraqis as "community care workers" (CCWs) to help orphans with trauma. Included in the initiative is a special children's book that LitWorld helped create. SICF also cosponsored a training program in June to strengthen the planning and performance capacity of Iraqi NGOs helping orphans. Beneficiaries: June training was delivered to Iraqi NGOs that reach about 10,000 orphans. The CCW training will start by training 30-40 Iraqis in 2012 with plans to "train-the-trainer" to develop more CCW's. Goal is to deliver services to thousands of orphans. Cost: \$15,816

**Widows and Orphans project:** SICF provided support to two Iraqi NGOs which provide food and clothing to orphans, advocate for children's rights, and sponsor camps and festivals. Use of funds included repairs to facility for orphan day care in the future. Funds were also set aside to hire widows in the future to care for orphans. Beneficiaries: These NGOs have registered approximately 2,500 orphans. Cost: \$11,500

**Caring for Street Children:** SICF rescued a center for street children in Iraq after previous donor funding ran out. The center helps extremely vulnerable street children by providing a safe haven, academic tutoring, healthy meals, recreation, and social services. Beneficiaries: 40 street children, including orphans, with plans to expand. Cost: \$7,950

**Surge of Love Flight:** Delivery of school supplies, shirts and stuffed animals to Iraqi orphans. Cost: \$2,000
