### **Supplemental Responses**

The James J. Capone Charitable Foundation (the "Foundation") is a private foundation that was established in 2007 through a trust instrument. The Foundation has not yet been funded. The settlor died in July 2014. Upon settlement of the settlor's estate, the Foundation will be funded. It is anticipated that this will occur sometime in 2015.

The Foundation initially applied for tax-exempt status in 2007. However, the Foundation's tax exemption was automatically revoked on May 15, 2011 for its failure to file a Form 990-series return or notice for three consecutive years. The Foundation is in the process of applying for reinstatement.

Per the guidance available on the Internal Revenue Service website (<http://www.irs.gov/Charities-%26-Non-Profits/Automatic-Exemption-Revocation-for-Non-Filing:-Frequently-Asked-Questions-2>) regarding reinstatement following automatic revocation, the Foundation is filing a Form 990-PF for each tax year since automatic revocation (2011, 2012, 2013 and 2014).

### **Part IX**

As noted above, the Foundation was established in 2007 but has not been funded. Currently, the Foundation is not engaged in any Direct Charitable Activities, and it does not have any Program-Related Investments.

### **Part XVI-B**

As noted above, the Foundation was established in 2007 but has not been funded. Because the Foundation is currently unfunded, it did not engage in any activities related to the accomplishment of exempt purpose during the tax year. It is anticipated that the Foundation will commence such activities during the year of initial funding.
