Form 990-EZ Part III	28	Through creative recruitment and retention strategies, the division has substantially grown to about 153 reserve officers. Along with newly hired officers, many retiring career officers who have vast police experience and specialty skills have transitioned to the division to serve as reserve officers. In 2011, the reserve police officer recruit academy class of 14 recruits was started and reserve officers worked as patrol officers, detectives, helicopter pilots, motorcycle officers, school resource officers, airport officers, transit officers, training officers, and tactical officers, among many other specialty police assignments. These reserve officers perform the same police duties as career officers, as volunteers and without compensation. This diverse group of reserve officers donated nearly 63,016 hours of police services to the citizens of Phoenix, which have a value of more than 3,680,361.21.
