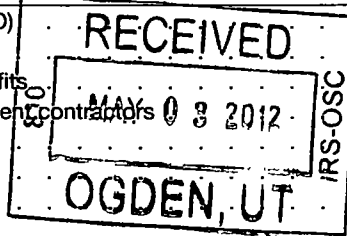

Main Street for conversion of the building into a new youth center. During 2011, \$17,344.68 was spent on renovation work.
