Austin Samaritans supports a variety of ministries in Nicaragua. We also support projects in Central Texas, Mexico, Guatemala, Zambia and Gabon through Computer Connections, our computer refurbishing operation.

4b (Code) (Expenses \$ 53,126 including grants of \$ 46,355) (Revenue \$ 2,769)
Fundacion Ortiz Gurdian-Fundacion Ortiz Gurdian (FO) provides prevention, screening, and treatment services for breast and cervical cancer to women in Nicaragua whose family income is less than \$2,000 per year. In 2010 over 3,700 women were screened. Of these, 209 received either outpatient or inpatient procedures. Austin Samaritans assists FOG by providing funding, medical equipment, supplies, medicines, and professional contacts with medical staff affiliated with M D Anderson Hospital.

Colegio Cristiano Presbiteriano is a Christian school that is owned and operated by the Mission of the Presbyterian Church of South Korea in Nicaragua. The school has 186 students in grades pre kindergarten through 9th grade. The school serves children in the impoverished Hialeah in Managua, Nicaragua. Austin Samaritans operates a student sponsorship program to provide funds to assist the school in meeting operational costs.
