ANIMAL RESCUES/TRANSPORT PLACEMENTS: The organization played an active and constant role securing funding and assisting in the placement of thousands of displaced animals, specifically from the Wild Animal Orphanage, the Montana Large Animal Sanctuary, the Houston SPCA and other rescue efforts.

STANDARDS, KEY PRESENTATIONS AND OTHER OUTREACH: The organization developed standards of safe and humane care for 23 major animal groups, provided individual mentoring, recognized sanctuary excellence with an award, conducted a national 2-day workshop and numerous conference presentations as well as free webinars relative to, among other issues, improving sanctuary operations. The organization also assisted sanctuaries in obtaining grant funding.
