The Friends of Coconino County Parks (FCCP) is a non-profit organization with the mission of supporting Coconino County Parks and Recreation Department's efforts in the areas of land conservation, park development, volunteerism and recreational activities FCCP accomplishes this through efforts that include 1) Generating funding to benefit County Parks, 2) Facilitating arrangements with volunteers and other organizations for cooperative work efforts and 3) Advocating for parks and open space	Expenses (Required for section 501 (c)(3) and 501(c)(4) organizations and section 4947(a)(1) trusts, optional for others)

28 Using just volunteer hours alone, FCCP was able to pay the County back in \$40,000 start-up funds and contributed an additional \$38,500 in value to CCPR Board members have contributed 590 hours, and volunteers at FCCP events (Wine Festivals, three years of Fair activities, and the Explore Your County Park series) have donated a total of 3,872 hours In partnership with Coconino Horsemen's Alliance, FCCP helped bring in \$13,250 to equestrian facility improvements at Fort Tuthill In partnership with Southwest Sustainable Forest Partnership, Northern Arizona Wood Products Association, AP Sawmill & Lumber, Loven Contracting, and Willow Bend Environmental Education Center, construction of a Shade Structure at Sawmill County Park is complete Grants in excess of \$50,000 have been obtained and the remainder of the funds came from the in-kind services of volunteers and donations of materials The flagstone floor, seat wall and landscape will be completed this spring with a Grand Opening soon to follow FCCP established two legacy funds The late Bruce Mason, a founding Board member, left \$575 to be used for the improvement of the County Fair The family of Michael Lunn established a fund to be used for the improvement of trails This fund has a current balance of \$1,250 with annual donations being made by various family members on the anniversary of his death The Annual Flagstaff Wine & Food Festival is now a recognized summertime event, attracting over one thousand attendees, and receiving rave reviews by vendors and sponsors In the 2010 and 2011 festivals, over 100 supporters volunteered for event planning and worked the event The third annual event is scheduled for June 9 We successfully operated the Beer/Wine Garden at the 2011 Coconino County Fair, providing friendly and helpful customer service and a great selection of drinks Other Fair vendors, our beer suppliers, and patrons commented positively about the operations All in all, we raised \$34,451 during the four-day event We had a total of 75 Fair volunteer hours including operating the beer garden and homebrew competition We initiated the Nature Walks and Bike Ride to the Fair Program of the County Fair in 2009, 2010 and 2011 Events with over 200 participants in total Our 2010-2011 "Explore Your County Parks" program, a series of outdoor recreational activities exploring county parks through bike riding, hiking or snowshoeing, had 75 attendees at 10 events (Grants \$ 69,373) If this amount includes foreign grants, check here	28a	250
