FMF ORGANIZED DAILY VOLUNTEER CALL SHIFTS TO ENSURE YOUNG CITIZENS PLAN TO VOTE ON OR IN ADVANCE OF ELECTION DAY. ON OCTOBER 31ST, FMF HELD ITS 6TH ANNUAL TRICK OR TREAT EVENT. DURING THE TRICK OR TREAT EVENT OVER 100 VOLUNTEERS FROM THE MISSOULA, GREAT FALLS, AND BILLINGS KNOCKED ON 5,400 DOORS TO REMIND CITIZENS TO VOTE. LEADERSHIP DEVELOPMENT: FMF PROVIDES A FULL-SPECTRUM, COMPREHENSIVE LEADERSHIP DEVELOPMENT PROGRAM FOR YOUNG PEOPLE AGES 14-29. SEMESTER-LONG INTERNSHIPS OFFER CIVIC ENGAGEMENT EDUCATION TO HIGH SCHOOL AND COLLEGE STUDENTS.
