## Summary of Activity 2011

- Presented 35 Bridge Sessions to approximately 3200 K-12 students from 30 different schools. All attended for free or greatly subsidized ticket prices. Sessions took place at World Cafe Live in Philadelphia and Wilmington.
  - Launched Bridge Sessions in Wilmington, Delaware, in partnership with the Light Up the Queen Foundation. 10 of the 35 sessions in 2011 took place in Wilmington.
  - Continued our partnership with the Philadelphia Orchestra's School Partnership Program, developing 5 new session topics that link classical music to other genres and feature collaborations of LiveConnections and Orchestra teaching artists and musicians.
  - Continued partnerships with Freire Charter School, Science Leadership Academy and St. Francis de Sales School, in which students from each school attend three Bridge Sessions over the course of the academic year. Approximately 75 students from Freire and 60 each from SLA and St. Francis participated.
  - More than 25 musicians from diverse genres presented Bridge Sessions.
- Expanded Classical Connections and re-branded as *ClassicAlive!*, aiming to expand the boundaries of classical music through repertoire, collaboration and atmosphere. Presented 6 *ClassicAlive!* events at World Cafe Live in Philadelphia and Wilmington with a total of 422 tickets sold and presented one pop-up performance at Reading Terminal Market.
  - Launched *ClassicAlive!* in Wilmington, Delaware, with a December brunch concert.
  - Paired artists and ensembles from different genres, including the Dali Quartet with Latin percussionist Alex Shaw, Dolce Suono, 6<sup>th</sup> Floor Trio, Network for New Music with poets Lamont Dixon and Jeanne McGinn, Serafin String Quartet and several members of the Philadelphia Orchestra.
- Received grant from the Knight Arts Challenge to launch Collaborative Connections, a new video initiative that will connect new audiences, particularly those unable to travel to the venue, to live music programming. Funds were matched by the Wyncote Foundation and 25<sup>th</sup> Century Fund and programming will launch in 2012. LiveConnections was one of only 36 organizations out of 1,700 applicants to receive this award.
- Won the 2011 Philadelphia "It Takes a Village" Human Values Award, presented by the International Association for Human Values Art of Living Foundation.
- In November, hired a General Manager, LiveConnections' first full-time staff member, to oversee daily operations and assist with programming, marketing and fundraising planning.
