- For the ongoing food, health, clothing and educational needs of the orphans in Cochabamba;
- To assist in maintaining the students in a rural boarding school;
- Supporting the technical training of street boys;
- To maintain the Bolivian Province, i.e. expenses for the fifty-two Sisters, the Council members, the Father Director and the Secretary of the Province, the subventions given to the houses that do not have sufficient salaries to cover their cost of living,
- Supporting over 400 students of EPARU, St. Ignatius Home, Amanecer and Solomon Klein. (EPARU is the work of Sister Mary Gerald McCloskey on the rivers of Trinidad. It is a rural pastoral work in the Beni) (E = equipo team, PA = pastoral, RU = rural).

Below is a special story of God's love for His Children, big and small:

San Vicente School is open for children from the different houses of Amanecer who are not yet ready for the regular schools as well as other children in need - some who live in the jails with their parents, others who come from home situations where they can't enter a regular school because of a lack of documents or financial ability to pay for the required books and physically handicapped children. The school also supports the education of students studying at ATENDI (a center for those with physical and mental disabilities) through the provision of classes within that center.

For the Day of the Child, a surprising invitation arrived, asking eight children, chosen according to their age, studies and economic status, to take a day trip to Santa Cruz with the airline Aviation of Bolivia (BOA). The children who were chosen spent the night in the school under the supervision of the Principal so that the following day they could be at the airport at 5:00 A.M. It was a night full of excitement and happiness. During the trip, the group of students from San Vicente de Paul demonstrated excellent behavior and responsibility. Together with the students from other schools, they visited places of interest within the city of Santa Cruz and returned to Cochabamba in the late afternoon. The parents and Amanecer educators waited to meet the children on their return from school, ending an amazing trip that seemed like a dream.

In April, a new child with disabilities and total paralysis (he can only move his head) enrolled in the school. Despite his physical limitations, he has an incredible strength of will and a great desire to succeed in his studies. He has shown special talent for math and is able to do the work holding a pencil in his mouth. Despite his difficulties, this child is a great example for all the students because of his spirit and commitment to a positive life.
