Other General Ministry This entails ministry to prevent child trafficking by supporting benevolence, outreach and humanitarian aide programs to the border communities where children are at-risk, traveling abroad to minister and host special conferences Our Thailand Foundation is based in Chiang Mai where we handle all legal, media, and business transactions in the main city The location also serves as a transit base for interns, teams and staff who are traveling to and from another country In addition to Chiang Mai we have a project office in Mae Sot, which is strategically located in the heart of the city It serves as a drop in base for all projects, meetings, and all administrative needs It is the hub of all business activity, such as bookkeeping, children's files, systems and organizational structure Other ongoing projects include the development of land purchased to eventually allow all of our homes to be in one location This will also serve as a self sustaining project and vocational training source for the children and people in all of our homes and programs The organization also occasionally supports projects that aren't officially part of Life Impact, but have the same vision, goals, and purpose of Life Impact
