The San Benito Health Program is located within the state of Peten in Guatemala This is a remote region of the country and underserved by most basic government services including health care, transportation, and education The San Benito Health Program supports community health workers for 25 rural communities The core health team, comprised of four full time advanced promotores and an accountant, maintains a clinic in the central area of the region to support the regional network of health workers and to provide clinical services to 10 to 15 patients each day The clinic and rural communities provide primary health care services to 5000 people each year including women's health care, prenatal care, common childhood illnesses, nutrition and oral health As well they provide consistent year round services to patients with chronic illnesses like diabetes, high blood pressure and asthma In 2011 there were 2,292 clinic visits and 1,019 rural home visits The health team manages 204 individual patients with diabetes and/or high blood pressure Finally, the team continued their preventive oral health program of applying fluoride to the elementary school children's teeth They visit the schools twice a year and helped 4442 children

Tanzania represents one the most biologically diverse countries in Africa, as well as one of the premier tourist destinations on earth The vast majority of Tanzanians have never had the opportunity to visit a Tanzanian National Park It is estimated that 95% of Tanzanians have never even seen a lion or elephant in the wild The reason for this is that the majority of Tanzanians do not have the means to pay for a vehicle, which is most often the required mode of transportation inside national parks Meanwhile, local people are frequently left to bear the enormous burden of living near protected wildlife Subsistence farmers frequently experience devastating crop losses due to raiding animals, and pastoralists must remain ever vigilant against carnivores like lions and cheetahs predating upon their cattle Despite these conflicts, people living in these areas are as enamored as anyone by the incredible beauty and majesty of wild animals, and are desirous of the opportunity to view and learn about them This project was founded upon the deep belief that without the support of local people, any conservation efforts aimed at protecting local wildlife species are doomed to failure Therefore, the aims of this project are to 1 Provide local people with the opportunity to directly benefit from living near wildlife in the most intuitive and perhaps meaningful way possible through personal experience 2 To begin a foundation of local support for wildlife conservation, and particularly elephant conservation at a time when African elephant populations are experiencing extreme pressure from illegal poaching The project is based in Ruaha National Park, which is the largest national park in Tanzania Ruaha is home to extraordinarily diverse and abundant populations of both bird and mammal species, including the second largest population of African elephants remaining in East Africa In 2011, the initial year of this project, 187 persons made visitations to the Park with the assistance of 12 dedicated volunteers
