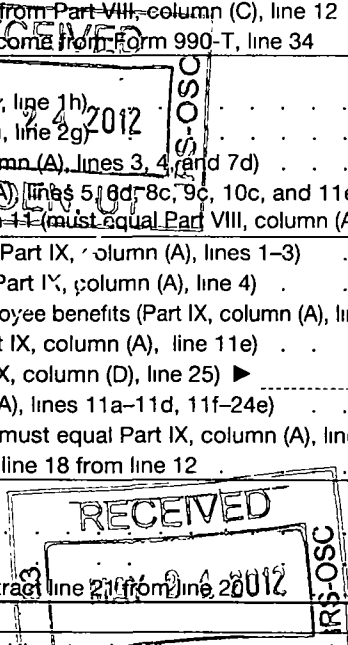

**GRANT MAKING:** The goal of our grant making program is to fund projects that apply whole systems thinking and scientific understanding to address critical issues of sustainability and resilience in the Puget Sound region. In 2011, we made grants totalling \$107,999 to 9 nonprofit organizations. The grant sizes ranged from \$1000 to \$20,559. The funded projects addressed a broad range of issues, including water quality, sustainable agriculture, and forest restoration. Our Grants Committee, comprised of 15 volunteers, employed a vigorous review and decision-making process over a nine-month period.  
 In addition, in 2011, we awarded four grants of \$250 each to previous grantees for additional reports on projects done in prior years.

**SEMINAR SERIES:** The goal of our Seminar Series is to bring together thought leaders and community members to learn from each other and develop solutions to some of the Puget Sound Region's most pressing sustainability issues. The 2011 Seminar Series covered the topics of biomimicry and biophilic design, individual and community rights, and ocean acidification. Seminars were open to the public and attracted an average of 150 people to each of the 3 seminars.

**Group Philanthropy:** The goal of our group philanthropy is to create a greater impact than individual donors could have alone by pooling their resources and involving them in a group process to identify and vet opportunities, shape programs, and advocate for solutions in the region. In 2011, Sustainable Path provided educational and engagement opportunities for donors, including issue briefings and the chance to participate in the organization's committees and work groups.
