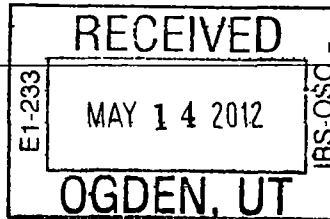

During 2011, we received a grant from the Spirit Mountain Community Fund to begin
a study. The goal of the project is to research the effectiveness of qigong
massage with young children with Down syndrome. Work began during the summer and
will be completed in the summer of 2012. Twenty participants were enrolled in the
study with half assigned to the treatment group and half assigned to the wait-list
control group.

A small, pilot study with children with sensory disorders was also conducted with
ten children. Positive results were obtained.

Three journal articles were published during 2011 regarding results of the
research on QST. At the end of 2011, two articles were "in press."

The Qigong Sensory Training Institute continued to expand its development of
educational materials on Qigong Sensory Training (QST). This included continued

One QST dual therapy course was conducted during 2011 to train professionals the QST treatment protocol. (The training consists of 5 initial days of training, 6 supervision sessions, 2 webinars and 20 treatment sessions for children over the course of 5 months.)

We sold 326 parent handbook/DVD packages and 59 copies of the QST documentary DVD, getting information about QST into the hands of more parents. We also made available in 2011 a DVD with a "self-care qigong" exercise for caregivers. We sold 100 copies of the self-care qigong DVDs.

QSTI continued to participate in the Global Autism Collaboration, a network designed to improve the exchange of relevant information among autism groups worldwide.
