Mission Program - Expansion International lead four mission teams of volunteers to Kenya in 2011. The teams provided medical services and medicines to 3,630 patients and distributed vitamins and parasite medications to 6,300 people. They hosted childrens programs for 7,500 children. They distributed 40,000 lbs of food, blankets and Bibles.

4b (Code:) (Expenses \$ 91,025. including grants of \$ 0.) (Revenue \$ 0.)

Kieni Resettlement Program - This is a refugee camp from tribal violence that houses over 800 families (over 4,000 people) in 13x13 temporary shelters. These families need to be resettled as they have been in the temporary shelters since 2001. In 2011 two brick making machines were purchased to start making the bricks that will be used to build the houses. A Christmas food distribution was also given to the Kieni people.

Scholarship Program - In Kenya public school is provided through 8th grade, students must then find a way to pay for a high school education. Many families cannot afford the cost of high school, so scholarships were given to 52 children for a year of high school which includes meals, uniforms and supplies. This education will enable these children the ability to be employed and the option to make a good life choices to live fulfilling productive lives.
