In 2011, Global Climate Change Foundation granted research funds to Columbia University for Rock Varnish Record of a Younger Dryas-age Wet Event in Northern Tian Shan, Western China - Tanzhuo Liu and Post Doc Support - Xianfeng Wang and Jimin Yu.
