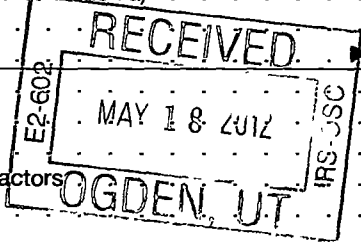



Witney's Lights is named after the late Dr. Witney Holland Rose, a University of Maryland Psychiatrist who was murdered in 2003 by her ex-boyfriend. Witney's Lights is a grassroots non-profit organization committed to eliminating domestic violence through awareness, education, prevention, advocacy, and a commitment to advancing the initiatives laid out in the landmark, Violence Against Women Act of 1994.
