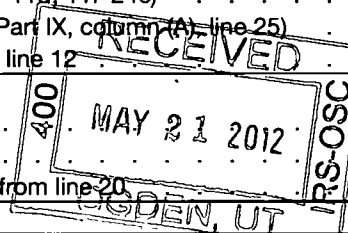

The undersigned, as the Secretary and keeper of the minutes and records of Morton Golf Foundation, certifies that the following is a true and accurate copy of the amendment to Article VII - Section 2 and Article VII - Section 3 of the bylaws of the corporation adopted at a meeting of the board of directors of the corporation duly called and held on October 13, 2011:

ARTICLE VII
DIRECTORS

"SECTION 2 NUMBER AND QUALIFICATION OF DIRECTORS


The board of directors shall consist of at least five (5) but not more than fifteen (15) directors, unless changed by amendment to these bylaws. The exact number of directors shall be fixed, within these limits, by resolution of the board of directors. Directors need not be residents of the State of California."

"SECTION 3. ELECTION AND TERM OF OFFICE OF DIRECTORS

Each director shall be elected at an annual meeting and shall hold office for a three (3) year term; however, if any annual meeting is not held or directors are not elected at any annual meeting, they may be elected at any special meeting held for that purpose. Each director, including a director elected to fill a vacancy or elected at a special meeting, shall hold office until the expiration of the term for which elected and until a successor has been elected and qualified. Election shall be by a majority of the directors then in office."
