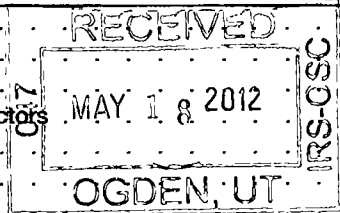

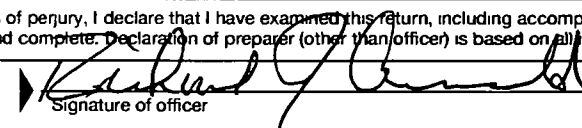

Section V, Line 34. Prior to January 1, 2011, ASHEcon was managed by iHEA. All revenues and expenses related to the operation of ASHEcon were maintained as a line item on the accounts of iHEA. 1/1/2011 ASHEcon became a totally separated from iHEA and contracted with NTA to manage all activities of ASHEcon for a total of \$75,000 per year.

Section VI, Line 49a. As explained in Section V, Line 34, ASHEcon paid the National Tax Association, a 501c3 organization, \$93,750 for management of membership activities, program activities, website and conference planning. Of that amount \$75,000 was for the calendar year 2011 and \$18,750 was for the amount owed for and unpaid in 2010. I do not believe this qualifies as a transfer as defined in the instructions but point it out here to guarantee full disclosure.
