Farm to School Program - DC Greens led school field trips at the Farm at Walker Jones, encouraging schoolchildren across the city to learn more about where their food comes from. In addition to our garden-based fieldtrip series, our Farm to School activities include the installation of a teaching kitchen within Walker Jones Elementary School, and educational enhancements at the Farm at Walker Jones to increase the Farm's accessibility.

Food Access Program - DC Greens runs a farmers' market incentive program at four markets in the District of Columbia (14th & U; Mount Pleasant, Bloomingdale, and Glover Park-Burleith) to increase access to local foods among low-income residents of the District.
