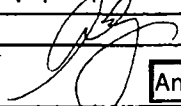

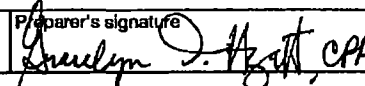

Aligned with Prospekt Mira's purpose of non-profit research and policy analysis, activities during the past year include engaging consultants to assist with statistical analyses for a United Nations Development Programme (UNDP) Knowledge Needs Survey Report. Additionally, with the Secretariat of the Pacific Regional Environment Programme (SPREP) acting as the Executing Agency and UNDP as the Implementing Agency, Prospekt Mira produced a promotional/informational video for the Pacific Adaptation to Climate Change Project (PACC) in Vanuatu. Prospekt Mira's video, entitled 'Vital Roads' was an official selection of the 4th annual Development & Climate International Film Competition sponsored by the Climate and Development Knowledge Network (CDKN). 'Vital Roads' was awarded a commendation and fourth prize overall in a film competition.

In 2011, Prospekt Mira also facilitated an internship in Tonga looking at water resource management issues. Working with a Westminster University in Salt Lake City, UT, Prospekt Mira trialled a 4 week pilot programme in June. The internship was coordinated under the supervision of Prospekt Mira director, Andrea Egan. The programme include a service learning component satisfied via an 8 day field visit to a Small Island Developing State in the Pacific (Tonga), coupled with a research-based work project in Auckland, New Zealand for the remainder of the 4 week programme. Outputs for the student included a summary report post-internship, and a fieldwork-related video highlighting the environmental concerns of Tonga.
