This is done through curriculum-based multi-day wilderness river programs that incorporate healthy risk-taking, leadership building, academic lessons, team-building exercises, and conservation education.

28 In 2011, GOALS worked with students from 4 schools to design and implement outdoor education programs. These schools include Rifle Middle School in Rifle, Colorado, Clear Creek Middle School in Evergreen, Colorado, Blevins Middle School in Fort Collins, Colorado, and St Marys School in Medford, Oregon. Students from these schools and their chaperoning adults accounted for 306 "user days" spent in canyons as a result of GOALS programs. These programs took place in Westwater, Desolation, and Cataract Canyons using the permits and professional guide services of Adventure Bound and Sheri Griffith Expeditions.
