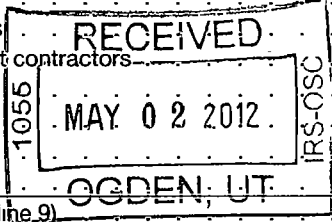

The objective of the foundation is to promote the rich and very old classical performing arts of South India to audiences in the United States, provide a premium performance platform for talented youngsters in the US, and present educational events by knowledgeable professional South Indian performing artists. In order to meet these objectives, in 2011, Pallavita organized concert tour for 3 vocalists and a violinist, with percussion and string accompanists. Performances were organized in 25 venues in the US and over 10,000 people attended these events. In addition Pallavita collaborated with US universities and museum to provide educational events by these artists. It included events at Harvard, Berklee College of Music, Wesleyan University and Asian Art Museum, San Francisco and other venues. Over 1000 students benefitted from these educational events. Pallavita organized a 3-day Festival in Fremont, CA. The Festival presented South Indian classical performances by over 250 youngsters from around the US and educational events by visiting Indian professional artists. Over 2000 people attended these events. All these events were open to the public.

\$36,926.08, the full amount in Line 16 of Form 990-EZ, was spent on travel, that included international travel from and to for 11 professional artists from India, cost of getting their P-3 Visa, domestic US travel for performances and educational events.

The full amount in Line 13 (\$61,150) of Form 990-EZ was payment of performance fees for the 11 professional artists from India for their concerts and educational events.

% of overhead to total expense was 6.73% and % of overhead to total revenue was 5.75%.

None of the members of the board or the executive staff were paid any remuneration.

The work for the events was done by volunteers. Event management was by volunteers as well.
